# CODE OF CONDUCT FOR PARENTS

## 7. Parental Authority and Legal Recourse:

Unless a legal document of guardianship is presented to the school administration, only parents are at liberty to approach school administration on behalf of their child.

### 8. Adherence to School Policies:

Familiarize yourself with and adhere to the school's policies, procedures, rules, and regulations concerning fees payment, attendance, discipline, dress code, and academic expectations.
